

LAST WILL AND TESTAMENT

of Jane Elizabeth Sample

1. **DECLARATION AND REVOCATION.** I, **Jane Elizabeth Sample** (born 14 May 1972), of 14 Rosewood Gardens, Anytown, Exampleshire, EX1 2AB, DECLARE this to be my last Will and Testament. I HEREBY REVOKE all former Wills and testamentary dispositions made by me.

2. **APPOINTMENT OF EXECUTORS.** I APPOINT the following persons to be the executors and trustees of this my Will (together, “my Trustees”):

If any of them shall die before me or be unwilling or unable to act, the survivor or survivors shall act as sole executor and trustee.

3. **APPOINTMENT OF GUARDIAN(S).** If any of my children is a minor at the date of my death and no parent with parental responsibility for that child survives me, I APPOINT the following as guardian of my minor children:

4. **SPECIFIC GIFTS.** Lorem ipsum dolor sit amet, consectetur adipiscing elit, sed do eiusmod tempor incididunt ut labore et dolore magna aliqua:

1. **Ut enim ad minim veniam**, quis nostrud exercitation ullamco laboris nisi ut aliquip ex ea commodo consequat, provided that person survives me by 28 days.
2. **Duis aute irure dolor** in reprehenderit in voluptate velit esse cillum dolore eu fugiat nulla pariatur, provided that person survives me by 28 days.

5. **RESIDUARY ESTATE.** Excepteur sint occaecat cupidatat non proident, sunt in culpa qui officia deserunt mollit anim id est laborum, sed ut perspiciatis unde omnis iste natus error sit voluptatem accusantium doloremque laudantium:

1. **Totam rem aperiam** (eaque ipsa) — quae ab illo inventore veritatis.
2. **Quasi architecto** (beatae vitae) — dicta sunt explicabo.

Nemo enim ipsam voluptatem quia voluptas sit aspernatur aut odit aut fugit, sed quia consequuntur magni dolores eos qui ratione voluptatem sequi nesciunt, neque porro quisquam est.

6. **POWERS OF MY TRUSTEES.** Qui dolorem ipsum quia dolor sit amet, consectetur, adipisci velit:

1. sed quia non numquam eius modi tempora incidunt ut labore et dolore magnam aliquam quaerat voluptatem;
2. ut enim ad minima veniam, quis nostrum exercitationem ullam corporis suscipit laboriosam;
3. nisi ut aliquid ex ea commodi consequatur, quis autem vel eum iure reprehenderit;
4. qui in ea voluptate velit esse quam nihil molestiae consequatur, vel illum qui dolorem eum fugiat quo voluptas nulla pariatur.

7. **FUNERAL WISHES.** At vero eos et accusamus et iusto odio dignissimos ducimus qui blanditiis praesentium voluptatum deleniti atque corrupti quos dolores et quas molestias excepturi sint occaecati cupiditate non provident.
